Session 1: **Introduction to the Legal System of PRC**

Session 2: **Transformation of Criminal Justice Policy in China**

Date: July 8, 2026

**In this session, I will describe the transformation of criminal justice policy from 1949, from the punitive policy to “balancing leniency and punitiveness”. I will also talk about the specific impact of this transformation on the routine operation of Chinese criminal justice system. The students are encouraged to make comments and raise questions during the course.**

Session 3: **Introduction to Chinese Criminal Law**

Date: July 9-10, 2026

**In this session, I will make introduction to the basic principles of Chinese substantive criminal law, basic elements of crime, justification and excuse, inchoate crimes, complicity, omission and possession, types of punishment, sentencing principles and guidelines, as well as some major crimes in the Special Part of Chinese Criminal Code.
